The day's only other presenter, [Ed Katz](#) of the [International Office Moving Institute](#), was the expert witness in two successful judgements for Maloof, Browne & Eagan's insurance company clients trying to recover monies paid in claims. In both cases, movers were found to be negligent on how they transported and handled fragile electronics that resulted in several hundred thousand dollars in damage.

"One of the reasons I agreed to speak at the seminar is that Maloof Browne & Eagan is AV rated reflecting the highest level of skill and

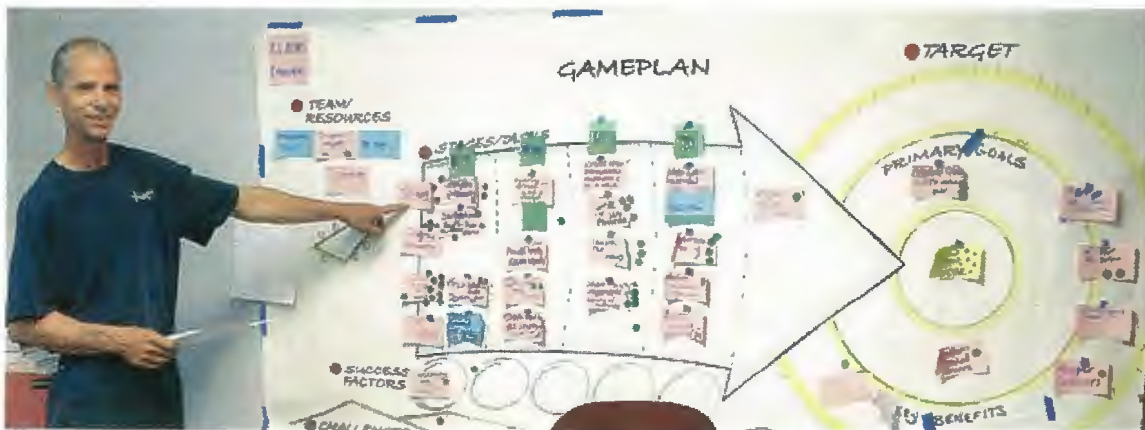
his own asking movers who was the best electronics hauler. The name *McCollister's* kept coming up.
